The Organization was advised by Labor Relations that there will be approximately 650 abolishment's issued by Mid November (primarily on the Tie and Rail Side). Due to the recent reductions, the Organization has reported these layoffs to the Surface Transportation Board.

Members who become furloughed and are seeking additional benefits, we have put together an information packet that includes the following:

- If you have worked 11 of the previous 30 days and are furloughed prior to a holiday, you are entitled to the upcoming holiday. To request payment for the holiday, please click on the below link to complete the request.
